# Presbyterian Homes of Georgia Communities

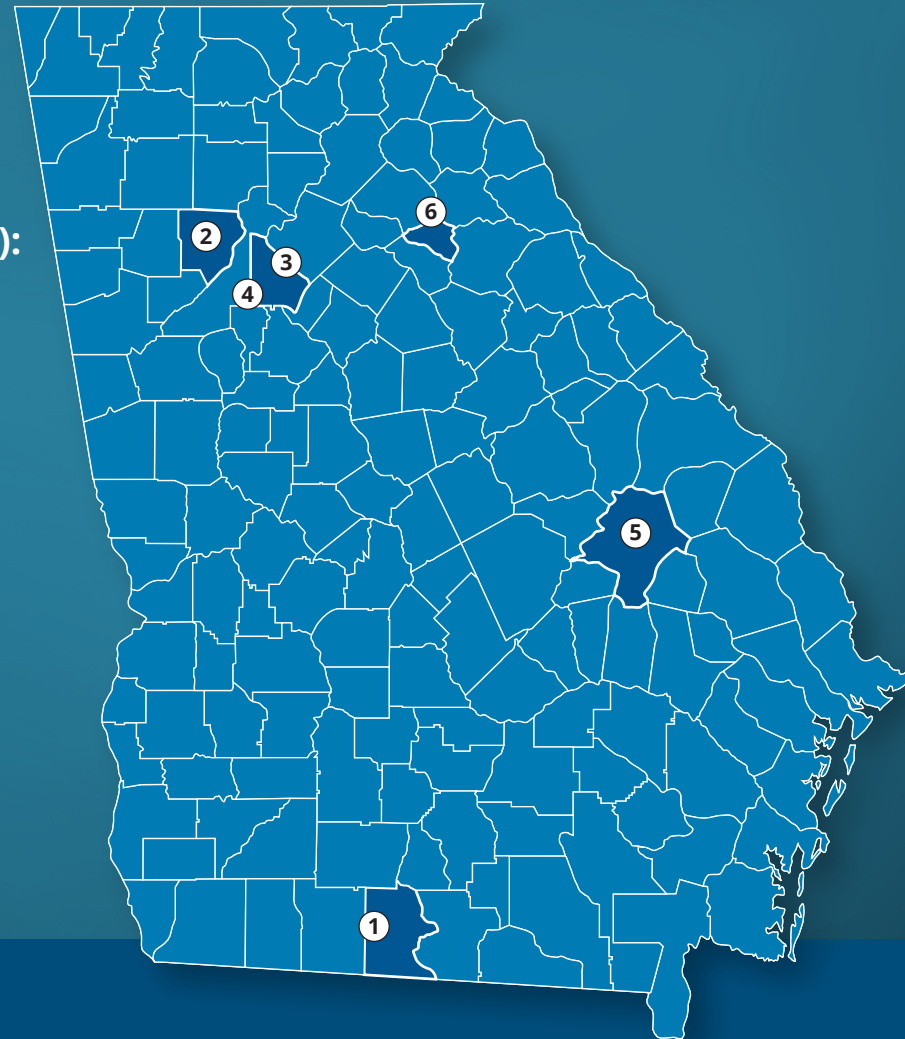
